The Committee meeting was called to order in executive session by Commissioner Steiner at 12:20 p.m. and ended at 12:41 p.m. The Committee also met in public session prior to the executive session.

Action on Minutes

The Secretary reported that the Minutes of the meeting of June 30, 2008 had been signed and distributed to the Commissioners.

Whereupon, the Committee approved the Minutes of the meeting of June 30, 2008.

MEMORANDUM OF AGREEMENT WITH THE UNION OF AUTOMOTIVE TECHNICIANS

It was recommended that the Committee on Operations (Committee) approve a tentative agreement with respect to amendments to the collective bargaining agreement with the Union of Automotive Technicians (UOAT), as representative of certain Port Authority employees, providing for changes in wages and benefits. This tentative agreement was entered into on June 4, 2008, subject to Committee approval, and was ratified by the UOAT members on June 14, 2008.

The UOAT is the sole representative of 125 Port Authority employees in the job classifications of Automotive Mechanics, Automotive Parts Technicians, Welders/Fitters, Maintenance Equipment Servicers and Machinists. The tentative agreement provides for, but is not limited to, the following modifications in the collective bargaining agreement:

1. A five-year term from August 23, 2006 through August 22, 2011, providing for annual wage increases of 3.33 percent.
2. Increases in safety shoe and eyewear allowances.
3. Increased premium for five holidays.
4. Enrollment into the Flexible Spending Program.
5. Outsourcing the retrofitting of 65 diesel-powered vehicles/equipment.
6. The right to discontinue cafeteria services at the George Washington Bridge, Holland Tunnel and Lincoln Tunnel.
7. The ability to reimburse petty cash through the PeopleSoft payroll system.
8. Elimination of a 15-minute break and excused time for banking on paydays.
9. More flexible utilization of two roving welder positions.

The Committee has the power to act on this matter under Article VIII, Section D, Paragraph (4) of the By-Laws.

Pursuant to the foregoing report, the following resolution was adopted by the Committee in executive session with Commissioners Bauer, Ferer, Holmes and Steiner voting in favor; none against:

RESOLVED, that, consistent with the Port Authority Labor Relations Instruction, the Committee hereby approves, for and on behalf of the Port Authority, an agreement with respect to amendments to the collective bargaining agreement with the Union of Automotive Technicians, as representative of certain Port Authority employees, providing for changes in wages and benefits and other terms and conditions of employment, with a term of 60 months, expiring August 22, 2011.
