Hi Tina,

As discussed, I've been asked to inquire about the amount of all payments made from the Port Authority to the City of Newark over the past 3 years.

From my understanding, the payments may be in the form of payments-in-lieu-of-taxes (PILOTs), lease payments, or car rental fees.

From the information I have, the Port Authority's facilities in Newark, the types of payments, and the NJ statutes authorizing the payments, are as follows.

- 1) Newark Liberty International Airport (lease agreement and car rental fees) (N.J.S.A.32:1-35.5)
- 2) Port Newark (lease agreement) (N.J.S.A.32:1-144 and 145)
- 3) Newark Legal & Communications Center (PILOT agreement) (N.J.S.A.32:1-35.82)
- 4) Essex County Resource Recovery Facility (lease agreement) (N.J.S.A.32:1-35.82)

Would it be possible to have this information by Friday, December 10?


