

Fine Organics Corporation is protesting the potential award of the contract for that referenced bid to Grignard Company, Rahway, NJ.

The basis of our protest is that item #2 for 4000 gallons of Cleaner, Exterior Acid shows “no substitutes” and Grignard, unlike Fine Organics; is not shown with an approved product and is therefore ineligible for the award for this item. Since it is the intent of the authority to make an award for both items to one vendor, Grignard should not be considered for the award. The award should be given to the lowest approved vendor, Fine Organics Corporation.

Please advise the determination of our protest.
