Hello Dan,

I would like to request, under the Freedom of Information Act, additional data related to violent crime and police staffing at JFK International Airport for the years 2005 to your most current information for 2011.

Specifically, I would like:

- The number of aggravated assaults reported at JFK International each year for that timeframe.
- The number of murders/non-negligent manslaughters reported each year for that timeframe.
- The number of robberies reported each year for that timeframe.
- The number of forcible rapes at JFK, if those were not included in the 32 police reports your previously sent me.

I would also like annual police officer staffing numbers for 2005 to 2011. I don't need patrol numbers, just the number of sworn officers assigned to the airport for each of those years. The FBI regularly reports this data for dozens of airports, including Hartsfield International and DFW, when they release their annual Uniform Crime Reports.

I make this request under the Freedom of Information Act and any other applicable open records laws in place in your state. If you decline any part of this request, please reference the statute that allows you to do so.
