As you may recall, I represent Cardet Construction Co., Inc. ("Cardet") in the above-referenced action (Ref. my letter of 3/29/11; FOIL Ref. 12237). Cardet was the general contractor to American Airlines Inc. ("American Airlines") for the construction of the Admiral Club and Flagship Lounge at Terminal 8 at JFK International Airport.


You have, by now, probably heard that American Airlines has filed for protection under Chapter 11 of the Bankruptcy Code.

Pursuant to §5 of the New York State Mechanic's Lien Law, I would request that the Port Authority of NY & NJ, as the public owner to Terminal 8 at JFK Airport, provide for me a copy of the bond which the Port Authority was statutorily required to demand of American Airlines, as the private entity for whom the public improvement is being made, guaranteeing prompt payment of moneys due to the contractor, his or her subcontractors and to all persons furnishing labor or materials to the contractor or his or her subcontractors in the prosecution of the work on the public improvement.
