Dear Sirs:

The undersigned is a resident of the State of New York and hereby makes the following Freedom of Information Law request under both New York's Freedom of Information Law and under New Jersey's Open Public Records Act.

The request concerns eleven construction projects which may have been completed around ten years ago. It does not concern any accidents or incidents in connection with these construction projects.

I refer you to the following eleven construction projects which have been identified to me as

1. Holland Tunnel HT- 264
2. Holland Tunnel HT- 110.022
3. Lincoln Tunnel LT-286
4. George Washington Bridge GWB-208
5. Lincoln Tunnel SCADA 234.012
6. EZ Pass Maintenance MF 274.038-M
7. George Washington Bridge Access Ramps 244.02
8. George Washington Bridge Fixed Sign Renovation GWB 244.110
9. Pulaski Skyway CCTV HT-442
10. Port Newark and Elizabeth Terminal Curves Signage Improvement MFP-994.554
11. Newark Airport Signage EWR 510.008

I seek the following information on each of these eleven construction projects:

- A. The full name of the construction project and identification number of the construction project assigned by the Port Authority of New York and New Jersey.
- B. The date the construction project was put out for public bidding
- C. The date bids were received on the construction project
- D. The date the construction contract was signed by the contractor and the Port Authority of New York and New Jersey or in the alternative the date of the construction contract as found in that document (specifying which).

- F. The amount of the contract as awarded. If the contract included unit prices, than the amount calculated under the quantities as estimated by the Engineer for such contract for purposes of bidding. I am not interested in the overall project cost which might include costs by designers, or materials separately purchased by the Port Authority of New York and New Jersey.
- G. The date the construction contractor was notified to proceed.
- H. The number of days provided for completion in the contract as executed (e.g., the time of performance), and whether this was from the date of the notice to proceed was issued, or in the alternative the completion date in the contract as signed.
- I. The final amount of the construction contract including all changes, adjustments and omissions to the contract.
- J. The date of final payment on the construction contract.
- K. The date of substantial completion of the construction contract.
- L. The date of final completion of the construction contract.
- M. The date the Port Authority accepted performance under the construction contract.

I also ask whether the information can be certified under NY CPLR 3122-a and/or Federal Rule of Evidence 902.
