Software Requirements:

1. Adjust its approach to classification without the need for human training or other manual intervention;
2. Discover anomalies based on behavior, rather than human-defined rules;
3. Allow for unique learning and event patterns based on time of day, day of the week, and other variables as determined;
4. Be capable of alerting on unusual activity, unusual interactions between two or more objects, unusual motion, or unusual path taken by an object in a scene;
5. Produce motion, activity, interaction, location, and trajectory learning models;
6. The software should be capable of analyzing and reporting unusual or abnormal behavior in the entire scene or field of view, without the need to mask out portions of the scene;
7. The software shall also provide image stabilization;
8. The software shall run on standard commercial off-the-shelf computer server equipment based on Intel processors;
9. The software must integrate with 3rd-party applications, including Situational Awareness Platform Software.
