Dear Secretary,

We represent Solenir Porto Machado, the proposed Administratrix of the estate of Luiz Mauro Machado (hereinafter "Mr. Machado").

We write this letter pursuant to the New York State Freedom of Information Law, Article 6 of the Public Office Law and the Port Authority of New York and New Jersey Freedom of Information policy.

We hereby request that Solenir Porto Machado and her retained counsel Viana Law Firm, P.C. be allowed to inspect or be provided with copies of the Port Authority Police Report issued in connection with the death of her husband Mr. Machado – which took place outside Terminal 8 at John F. Kennedy Airport (hereinafter "JFK"), Queens, New York on March 28, 2013 (hereinafter referred as "the incident").

Further, we request to be allowed to inspect or be provided with copies of (i) the images from Port Authority cameras installed outside Terminal 8 at JFK Airport on March 28, 2013 from 1:00pm to 6:00pm; (ii) any and all statements related to the incident, (iii) any and all written communications and documents related to the incident, (iv) names, titles, addresses and telephone numbers of the Port Authority officers who witnessed the incident or who responded to the location of the incident and drafted the Port Authority police report, (v) any and all documents related to the incident, (vi) any and all correspondences, emails, memoranda, charts, images or voice recordings related to the incident (vi) any and all material information and document responsive do the incident.
