Under the Freedom of Information Law, I'm requesting data that shows the number of illegal firearms recovered by officers from the Port Authority of New York and New Jersey within the City of New York from 2003 through 2013. I'm requesting that this data be broken down for each year, 2003 through 2013. I'm also requesting that these totals do not include illegal firearms that are recovered as part of "gun turn-in" events, or any other similar types of events.

If in your view any of the above records contain information you deem to be exempt from disclosure please redact that portion of the record and provide the remainder, specifying the precise nature of the redacted information and the specific exemption on which you would rely in the event I was to ask for its disclosure.


