

Due to substantial damage from call 4-4 (see related linked entry), the subject aircraft was prepared for disposal and salvage and transport off LGA property via barge. The following is a chronological of the events that took place to remove the aircraft via barge from the 22 deck between the VOR pier and drive out pier.

Present for the operation was 103 DS, 104 ALG, 100 KD, 98 FL and 98 ES. Staff from Southwest were on hand to assist Don Jon Marine who was the contracted recovery team for Southwest.

The subject aircraft was 'picked' off the 22 deck and transported to Port Newark where it will be stored until further notice.

2330hrs - Incident Command established on 22 deck.

2345hrs - LGA closed to all fixed wing aircraft. Don Jon Marine spud barge and lift barge moved from outside LGA exclusion zone into position to 'pick' and receive aircraft off the SE corner of the 22 deck btwn the NAVAID drive out pier and VOR pier.

Note: Rwy 22 Glide Slope was shut down by FAA @ 1600hrs on 10/19 and the VOR was shut down @ 2100hrs because of reflections from crane. Both NAVAIDS were activated btwn 0500/0700hrs on 10/20 as per MA.

0000hrs - Aircraft under tow from hgr 5 ramp, via Twy E, Rwy 4-22 to Twy R (SE corner of 22 deck).

0021hrs - Spud barge and pick barge now anchored approximately 20 feet off deck. Note: high moon tide prevented spud barge from securing to bottom of the bay further out as planned.

0059hrs - Aircraft backed into position; rigging crew installing hoisting and lift straps.

0126hrs - Rigging completed and aircraft ready for lift.

0134hrs - Successful lift in progress...no problems thus far.

0210hrs - Subject aircraft is officially off airport grounds. Spud and pick barge are being pushed back out of LGA exclusion zone by two tug boats with aircraft hoisted over water.

0230hrs - Both barges are now anchored outside of LGA exclusion zone with aircraft suspended over water awaiting transport barge. Tug boats on the move to tow/push transport barge under aircraft.

0250hrs - Transport barge in place and prepared to receive aircraft.

0345hrs - Aircraft secured on transport barge and being transported to Port Newark at this time. All units securing.

Special inspection conducted, Incident Command secured.
