Hello Gentlemen,

I am trying to go about this in a civil matter. I have sent a Freedom of Information request for the surveillance footage from the cameras in the surrounding areas where the assault I endured from driver 38216 15 times since the assault. I have also requested the officer's notes that responded five minutes into the altercation, because the officers from July 19, 2014 did not document the assault and now I'm told there aren't notes. The rest is summed up in my last Freedom of Information request:

Request for the surveillance footage from all cameras around gate 75 in the Coach/Peter Pan lower garage area from July 19, 2014 1:30 AM-2:10 AM. Also the female patrol officer's notes which contained the driver's, the witnesses, and my own statement of what happened. I know there are notes because I saw them as I "had" to sign her pad. Third I am requesting the documentation of Port Authority Detective Scheffold, Sargent Nicholas, and Sargent Ross's determination that the driver 38216 be charged with third degree assault, CCR 14B517.
