Please accept this letter as a supplemental response by The Port Authority of New York & New Jersey ("Port Authority") to your records request of September 25, 2015. We enclose 2 pages of responsive documents.

1. Copies of documents known as special passenger assistance forms related to Governor Christie's access to and assistance through Newark Liberty International Airport between Jan. 23, 2013 and Feb. 8, 2013.

Port Authority Response: There is one document responsive to this request. As the Port Authority informed you on December 8, 2015, this document falls under exemption from disclosure for records implicating security concerns, an exemption which is recognized under OPRA. However, in furtherance of the Port Authority's records policy of enhanced transparency, upon consultation with the Superintendent of Police/Director of Public Safety of the Port Authority Police Department, and the New Jersey State Police and Bureau Chief of the Executive Protection Bureau, the Port Authority is providing you with the document in redacted form.

2. Emails, memos, or other written communications between, to, or from Port Authority aviation employees and Port Authority police related to the preparation and facilitation of Governor Christie's access to and travel through Newark Liberty International Airport during the above dates.

Port Authority Response: There are no documents responsive to this request.

3. The same documents as above related to passengers who were traveling with Governor Christie during the above dates.
