Any and all Portions of the Port Authority-Office of Inspector General (OIG) Investigator's Directives relating in any way to the preparation of field notes of interviews with witnesses, subjects, or targets of criminal investigation; timeliness of preparing an Report of Investigation after an interview of a witness, subject or target of the investigation and the execution of an arrest warrant after it is obtained for the years 2009 through 2012.

Portions of the Port Authority-Office of Inspector General (OIG) Investigator's Self Inspection Checklists or reports relating in any way to the preparation of field notes of interviews with witnesses, subjects, or targets of criminal investigation; timeliness of preparing an Report of Investigation after an

interview of a witness, subject or target of the investigation and the execution of an arrest warrant after it is obtained for the years 2009 through 2012.
