

The Port Authority of New York and New Jersey ("the Authority") hereby accepts the offer of Guardian Service Industries, Inc. ("Guardian") to perform services under the above referenced Contract ("Contract"). The term of the Contract shall commence at 12:01 AM on February 1, 2007 and shall expire, unless sooner terminated, revoked or extended in accordance with the provisions thereof, at 11:59 PM on January 31, 2010.

The Contract between the parties shall consist of the following items. In case of conflict or inconsistency between any of the items, the earlier listed Item shall take precedence over the later listed item:

1. This Letter of Acceptance.

3. Guardian's agreement to provide a Letter of Credit as security for the performance of its obligation under the Contract in the amount of \$1,400,000.00 with annual reductions as stated in its Best and Final Offer dated August 16, 2006. The Letter of Credit shall be issued in favor of the Authority by an investment grade bank located in the Port District. The form of the Letter of Credit shall be subject to the approval of the Authority's Credit Manager and shall be submitted to the Authority in draft format for review prior to the execution of this Letter of Acceptance by the Authority.
4. Guardian's Best and Final Offer, other than pricing, dated August 29, 2006.
5. Guardian's Best and Final Offer, other than the amount of the Monthly Management Fee and its components, dated August 22, 2006.
6. Guardian's Best and Final Offer, other than pricing, dated August 16, 2006.
7. Guardian's Best and Final Offer, other than pricing and Letter of Credit proposal, dated August 14, 2006.




